 magnitude similar to Katrina or Bande Aceh and the bulk of the national and international response will simply not even begin to arrive before day 4.After the Impact is aimed at beginning discussions about how isolated communities might deal with their own problems until enough outside assistance is re-established to move injured out and supplies in.

 following statement,"Communities in lower priority areas found they needed to be self-sustaining for weeks." I don't represent any lower priority
communities and I challenge any
responsible elected official to step forward and say he/she does.

So let's talk about creating community responses that serve
our people's needs.

* Discuss a community plan for Joyce, WA.

The vague time of year injects many potential contextual alterations into the scenario:

1) For instance, 8 PM in late May (Pacific Peril's time of event) means most people are home or heading home while 1:45 PM in late winter means most people are still at work or school. This changes the entire early-responder/ volunteer dynamic.
2) It also changes weather and daylight considerations which influence rescue activities and recon of damage. Time of day and time of year are important considerations, i.e., - nice summer day versus lousy winter day.

## The Joyce Scenario



## Day 1

(Night Situation)
Situation as of January 20, 1650 hrs - Provides an estimate of the situation

# A magnitude 9.2 CSZ earthquake struck 130 miles off Pacific Northwest Coast with duration of 4.5 minutes. 

# The entire west end of the 

 Olympic Peninsula subsided (sunk) 6 feet and seawater rushed in to cover the new beach. The tide stage at 1745 hrs is 9 feet, which added to the loss of 6 feet from subsidence, is now 15 feet.Surf is washing over the road at Crescent Beach and the Twin Rivers. A tsunami warning has been issued but with communications down, few hear it.

Weather - Temp $35^{\circ}$, rain heavy is expected for the next 24 hrs , snow level 1,000 feet, visibility $1 / 4$ mile with winds from the south gusting to 25 mph . Soils are saturated.

## Communications - Road

 conditions are unknown but it is suspected that the Elwha River, Salt Creek, Lyre River and Twin Rivers bridges have collapsed and that slides and liquefaction have cut Hwy 112 at the Twin Rivers and the Piedmont Road to Lake Crescent.
# Utilities - The Clallam County 

EOC is off the air. There is no power or phone service and cell phone systems are out. The water system has lost pressure.

## Buildings - The Joyce Fire

 Protection District 4 firehouse collapsed on the equipment. The masonry structures at Crescent School collapsed and the grange and Laundromat are destroyed.

## Individuals - By 1730 hrs and

 until further notice, rescue, evacuate out and stay out of tsunami zone, shelter-in-place, in RVs or with near-neighbors if possible, evacuate to Joyce only if necessary. Emergencyservices may be available in Joyce after 2100 hrs.

## Community - Establish aid

 station/shelter in Joyce, prepare to offer limited emergency services by 2100 hrs at the aid station/shelter, get fire equipment out of Joyce firehouse, establish some kind of communications with Clallam County EOC.Recon Hwy 101, Piedmont Road, Freshwater Bay Road and Camp Hayden Road. Move school buses to aid station shelter for emergency warming, mobilize volunteer assets for morning recon.


## Execution

## Individuals - Proceed to high ground

 if in tsunami zone, rescue trapped individuals, if possible, and take shelter for the night to avoid hypothermia. Unnecessary travel after dark should be discouraged.

## Community - Law enforcement,

FPD\# 4 personnel, public employees and other selected individuals will mobilize at Joyce General Store at 2000 hours to assess damage to Joyce buildings and decide where to establish the aid station/shelter.


## Keeping in mind the reality of after-shocks, these people will

 make necessary temporary repairs and try to establish emergency heat, power and sanitation along with signage directing people to the facility. School buses will be moved to the shelter for emergency warming.Recon Hwy 101, Piedmont Road, Freshwater Bay Road and Camp Hayden Road. Move school buses to aid station shelter for emergency warming, mobilize volunteer assets for morning recon.


An equipment operator will use the loader at the DOT sand stockpile to lift the roof off the fire house so the equipment can be moved out (NOTE: This loader is only on site during the winter).


## Makeshift repairs to the fire

 equipment are to be made during the night. Communication in the community and with the EOC may be possible via police/fire radios or CB radios until HAM facilities can be established at the site.
# Law enforcement is to immediately 

 lock down the fuel at Joyce General Store and Crescent School. Law enforcement is to scout Hwy 101, Piedmont Road, Freshwater Bay Road and Camp Hayden Road.

Restaurants and the
stores are to immediately conserve food, water and sanitation supplies. Collect rainwater.
Unnecessary travel after dark should be discouraged.


## Admin and logistics

## Individual - People need to

 communicate with neighbors and assist as needed. Make do with what you have until daylight, relocate to RVs, near-neighbors or evac to Joyce as a last resort. Limit travel at night as much as possible.

## Community - State Patrol,

 Sheriffs, Corrections Officers in the area at the time of the event, PUD, Crescent Water, School District, state, county and city workers and other publicpersonnel will be the core of the response and recovery effort until road communications is reestablished with Port Angeles.

## Day 2 <br> (Morning Situation)

Situation for Daylight hours of January 21, 0500 hrs to 1700 hrs

## After-shocks continue to occur with one as large as magnitude 7.5.



## During the night, tsunamis in the

 range of 20 feet above tide stage with an additional 6 foot run-up struck the coast of the Strait between the Twin Rivers, Crescent Beach and FreshwaterBay.

# Everything below a pre-quake elevation of 35 feet above sea level is either destroyed and/or covered with debris. 



# The strait began to settle down about 0400 and no new tsunami warnings have been issued. There is a lot of floating debris. 

Weather - Temp 35, rain heavy in morning easing to showers during the next 12 hrs. Forecast is for clearing and colder tonight with freezing level dropping to sea level and improving visibility.

Communications Police/fire radio communications has
been established with the Clallam County EOC. Limited scouting during the night established that the Elwha River, Salt Creek, Lyre River and Twin Rivers bridges collapsed.

# Significant liquefaction at MP 58 

 closed Hwy 112 for $1 / 2$ mile. A detour though Eden Valley and Dan Kelley Road has been established. Highway 112 at the Twin Rivers is closed due to landslides, liquefaction, and tsunami debris.Survivors are stranded on Hwy 112 west of the Twin Rivers. Numerous localized road failures at small bridges, culverts and fills make the following roads passable to horses, ORVs and some 4 wheel drive vehicles only - Hwy 112, Freshwater Bay Road, Camp Hayden Road, Eden Valley Road, Dan Kelley Road and Place Road.

Crescent Beach Road has been destroyed at west Crescent Beach and will need major reconstruction. The Camp Hayden Road has localized road failures and slides but could be reopened for evac and resupply through Crescent Beach if a bridge can be built at Salt Creek.

## Tsunami debris blocks Crescent Beach and the Freshwater Bay boat ramp and will hinder marine evac/resupply if not dealt with.



# Slides block Piedmont Road, cutting off communication with Lake 

 Crescent ...
but a resident hiked the 4.5 miles to Joyce during the night and reports landslides into Lake Crescent created waves as high as 10 feet and have damaged homes and roads along the lake.

Utilities - There is no power or phone service and cell phone systems are off the air. The water system continues to have no pressure.

# Buildings - EMS equipment has been pulled out of the collapsed Fire Protection District 4 <br> firehouse. The Freshwater Bay firehouse is damaged but usable. 

# The Joyce General Store, Joyce Bible Church \& gym, Church of Latter Day Saints, Storage Garages, strip mall \& Family Kitchen are damaged but usable.

## Individuals - House to house

 search for injured and at risk people. Evacuate injured and at risk people to Joyce, assess and repair damage to homes/shelters,If homes/shelter is untenable, evac to RVs or available
neighboring shelter or to Joyce if necessary.

If family is secure, able-bodied people should mobilize to Joyce for job assignments, conserve food and fuel.

## Community-Recon

 community roads and support house to house search as needed, set up ferry across the Lyre River at Norman's, rescue people west of the Twin Rivers, establish contact with Lake Crescent community,
# use daylight to improve shelter/aid station, arrange <br> helicopter or boat medivac if possible, inventory boats, heavy equipment and operators, prioritize use of boats and heavy equipment. 

Crescent water to see if water service can be restored, Inventory and conserve food and
fuel at Joyce General Store,
Restaurants, school, churches and grange.

## Execution

## Individuals - Conduct house to

house search for injured or at risk people, Assess and begin repairs to home/shelter or move to RV, set up basic sanitation, take shelter to avoid hypothermia. Unnecessary travel should be discouraged. Conserve food and water.

## Community - Law enforcement

personnel with school buses and Fire Protection District 4 equipment and personnel will be placed at Hwy 112 intersections to receive injured or at risk individuals. Equipment with lifting capability will respond as needed for rescue extrication.

# Heavy equipment as available will try 

 to reopen Hwy 101, and Piedmont Road. Freshwater Bay Road and Camp Hayden road are next priority. Use local boats and cable to set up ferry across Lyre River.
## People with carpentry

 skills will improve theaid station shelter and prepare
temporary shelter and try to rig emergency heat,
power and sanitation.


# Volunteers in the Salt Creek area will 

 try to establish an aid station/shelter at the Salt Creek Inn. Volunteers in the Freshwater bay area will try to establish an aid station/shelter at the Freshwater Bay FPD\#4 firehouse.
## Horse back riders/ ORVs will

 establish contact with Lake Crescent and rescue stranded people west ofthe Twin Rivers. Crescent Water employees to recon water system.


An equipment operator will use the DOT loader to reopen the Freshwater Bay boat ramp. Communication in the
community and with the EOC is
now possible via police/fire radios.

## HAM radio facilities are established

 at the site. Collect rainwater. Fuel, food and water are being rationed. Unnecessary travel should be discouraged.

## Individual - People need to

 communicate with neighbors and assist as needed. Make do with what you have, relocate to RVs, nearneighbors or evac to Salt Creek or Joyce as a last resort. Limit travel at as much as possible.Community - State Patrol, Sheriffs, Corrections Officers in the area at the time of the event, PUD, Crescent Water, state, county and city workers and other public personnel will be the core of the response and recovery effort until road
communications is re-established with Port Angeles.

 helicopter delivered several medics and medical supplies and removed several severely injured individuals to Port Angeles.

# After-shocks continue to occur but no new tsunami warnings have been issued. 

# Weather - Temp 32. Forecast is for clearing and colder tonight with lows in the 20s. Expect rain/snow in 24 hours. 



# Communications - Police/fire 

 radio communications continueswith the Clallam County EOC. The house to house search was completed and found approximately 200 injured, 12 dead and 80 at risk people.

Those needing care have been moved to Joyce or Salt Creek Inn. Hwy 112, Freshwater Bay Road and Camp Hayden Road are open but with one lane traffic in many places and it is necessary to ford some streams.

The ferry across
the Lyre River has
been installed. The
Freshwater bay
boat ramp is open but debris on the water makes it too dangerous to use
 boats after dark.

## The aid stations and shelters

 have heat, generators and sanitation. Contact with Lake Crescent and Lake Sutherland has been established but many homes around both lakes have been destroyed by waves from generated by landslides.
# The Piedmont road is covered 

 with slides and debris but a cat trail has been pioneered to Log Cabin Resort. Hwy 101 isblocked along Lake Crescent by debris and slides and by slides at Lake Sutherland.

## People are sheltering in place but

 will need a way out tomorrow. There are many casualties. People west ofthe Twin Rivers have been evacuated to Joyce.


Utilities - There is no power or phone service and cell phone systems are off the air. The water system continues to have
no pressure. Crescent Water employees estimate several weeks before service is restored.

# Buildings - The Joyce General Store, Joyce Bible Church and 

 gym, Church of Latter Day Saints, Storage Garages, Salt Creek Inn and strip mall are all being used as temporary shelters. The family Kitchen is the community food service.

Individuals - Continue to shelter-inplace, improve shelters, if family is secure able-bodied should mobilize to Joyce for volunteer assignment, conserve food and fuel. Avoid unnecessary travel.

# Community - Maintain, monitor and 

 improve aid stations/ shelters. Respond to emergencies as needed, communicate with EOC to arrange helicopter resupply and evacuations from Crescent School football field. Begin to coordinate boat evacuation/resupply effort with EOC.
# Overnight, volunteers will try to get 

 one lane of Piedmont Road open to Lake Crescent so people can evac toJoyce if necessary. Prepare for additional evacuees from Lake Crescent and Lake Sutherland. Inventory heavy equipment and operators and prepare heavy equipment assignments for next day.

## Conserve food and fuel at Joyce General Store, Restaurants, school, churches and grange.
